#### Sir Doctor Harisingh Gour

Sir Doctor Harisingh Gour (26 November, 1870 – 25 December, 1949) was a distinguished lawyer, jurist, educationist, social reformer, poet, and novelist. Dr. Harisingh Gour was the first Vice-Chancellor of the University of Delhi and Nagpur University, founder and Vice-Chancellor of the University of Sagar, Deputy President of the Central Legislative Assembly of British India, an Indian delegate to the Joint Parliamentary Committee, a member of the Indian Central Committee associated with the Royal Commission on the Indian Constitution (popularly known as the Simon Commission), and a Fellow of the Royal Society of Literature.

It was upgraded to a Central University on 15<sup>th</sup> January 2009 and was accredited 'A+' Grade (3.38 score) by NAAC in the Fourth cycle.

The University offers multidisciplinary academic programs at undergraduate, postgraduate and doctoral levels through its 11 Schools with sound infrastructure and innovative approach for teaching. The University has well equipped laboratories with modern and sophisticated instruments to encourage quality research. Besides the departmental libraries, the University has a Central Library with approximately four lakh books, e-books and e-journals. Under the INFLIBNET and DELNET programs, the students and faculty can access valuable sources of literature. The University campus is Wi-Fi enabled.

There are separate hostels within the campus for boys and girls pursuing various programs upto doctoral level to provide a safe and congenial Gurukul-like environment of learning. In addition, facilities like stadium, gymnasiums, sports complex, playgrounds and open-air theatre are also available to cater to the extracurricular requirements of the students.

The University has an adequate number of competent, dedicated and trained faculty members to enhance the knowledge of the students. The courses are well designed and suited to the present day demands. The faculty is involved in developing innovative methods of teaching and learning with the help of an in-campus Educational Multi-Media Research Centre (EMMRC). Under the ageis of the UGC, New Delhi, the Malaviya Mission Teacher Training Center (Formally UGC-Human Resource Development Centre) conducts orientation and refresher programs for the faculty. Recently, a Day care centre is established in the university campus.

To create high-quality academic ambience and to motivate and enthuse our students towards perfection in their academic endeavors, we offer meticulously designed and diverse curricula as well as optional courses at graduate, postgraduate and doctorate levels. Besides, the University has an Institute of Distance Education (IDE) enabling our students to pursue PG Diploma courses with regular PG/Ph.D. programs to enhance their employability. B.Tech. programs are also being offered under the Institute of Engineering and Technology.

The University is proud of the numerous academicians, administrators, judges, philosophers, writers, poets, critics and artists who have brought laurels to their Alma Mater in the last seven decades.

#### **University at a Glance**

The founder and mentor Sir Doctor Harisingh Gour desired to establish an educational institution to provide the opportunity of higher learning for a rural and deprived population of Central India. He was inspired by Cambridge and Oxford Universities as the models. The University of Saugor, later renamed as Doctor Harisingh Gour Vishwavidyalaya in February 1983, was established on



July 18,1946 by him out of his lifelong earnings. The University was the sixteenth university in the country and the first in the State of Madhya Pradesh at that time. The University was upgraded as Central University on January 15, 2009, by the Central Universities Act, 2009. The President of India is the Visitor of the University.

The University campus is spread over an area of about 1300 acres, surrounded by lush green forests, and is situated in the natural and eco-friendly environment. The University provides a congenial academic atmosphere to the learners to nurture their potential for excellence. There are 38 teaching departments, Institute of Engineering & Technology in the University, some of them are recognized centers of the UGC and DST under the DRS, PURSE and FIST schemes. There are four hostels for boys and four for girls. Residential facilities are available in campus for teachers and officials of the University. Our first Prime Minister Pt. Jawaharlal Nehru laid the 'foundation stone' of the University Library in 1952, which is named after him.

The University has adopted 'School of Study' system for promoting intra and inter school academic programmes. Eleven schools were established under the new system, which offers courses ranging from Physical Sciences to Applied Sciences and Technology, Law, Business Management, Applied Geology, Pharmaceutical Sciences, Humanities, Arts & Information Science, Social Sciences, and Music & Performing Arts.

The University has well qualified and experienced faculties (www.dhsgsu.irins.org) who are continuously engaged in providing quality teaching and research to the knowledge-seeking young scholars. Some of the faculties have the experience of working in internationally renowned educational institutes.

The Bank, Postal, Health & Sanitation and Cafeteria services are available at the University premises. There is an auditorium for indoor games and a playground for outdoor games as well as a well-equipped and furnished Golden Jubilee Hall with a seating capacity of 750, Abhimanch Hall over 200 persons to facilitate the cultural and academic activities.

The University has various centers for developmental activities such as UGC- Malaviya Mission Teacher Training Center (Formally UGC-Human Resource Development Centre), Center for Advance Research (CAR), Institute of Distance Education, Study centre of Indira Gandhi National Open University (IGNOU), Educational Multi-Media Research Centre (EMMRC), Teaching and Learning Centre (TLC), Remedial Coaching centre, Community College, Population Research Centre (PRC) of Ministry of Health and Family Welfare and Manuscript Research Centre of the Ministry of Culture, Day care centre, are Institute of Engineering & Technology (IoET) and facilities for SLD/PWD students.

Academic departments, Hostels and Libraries are well equipped with Wi-Fi through National Knowledge Network (NKN) and e-resources are accessible through Wi-Fi. The Integrated University Management Systems (IUMS), Samarth portal for ERP and Learning Management Systems (LMS) are available for providing all the possible online facilities.



#### **Centre for Advanced Research (CAR)**

CAR aims to support and strengthen the scientific research and teaching by providing state-of-the-art instrumentation and expertise in applications of highend sophisticated instruments to the researchers and students of university and other institutions. The CAR at the Dr. Harisingh Gour Vishwavidhyalaya, Sagar is equipped with Nuclear Magnetic Resonance Spectrometer, Single Crystal X-Ray Diffraction, Powder XRD, LC-Mass Spectrometer, Scanning and Transmission Electron Microscope, Nanospary Drier, Particle Size Analyzer, Q-PCR and many more such instruments to facilitate our goal.

This facility was developed with support from UGC, New Delhi, and the DST-PURSE scheme. It is proudly associated with the ambitious i-STEM scheme (Indian Science, Technology and Engineering Facilities Map) of the Government of India (https: www.istem.gov.in) to ensure Optimal Usage of R&D Resources. Since its inception in 2014, a number of high-impact research publications have been published with the help of instruments available at CAR. We welcome all the scientists, research scholars and students to utilize this facility for analyzing their samples and producing world-class publications. Details of the instruments and charges thereof are provided herewith.

#### Admission to Ph.D. Programmes 2025-26

#### 1.0 Guidelines:

As per University Grants Commission (Minimum Standards and Procedures for Ph.D Programme) Regulations, 2022 issued though THE GAZETTE OF INDIA: EXTRAORDINARY, NEW DELHI, THE 7<sup>TH</sup> NOVEMBER, 2022 followed by notification No. F.4-1(UGC-NET Review Committee/2024 (NET)/140648, dated 27<sup>th</sup> March, 2024.

#### **Call of Applications:**

Applications are invited for admission in Ph.D. Programmes for session 2025-26. Eligible applicants may apply online through University website <a href="www.dhsgsu.edu.in">www.dhsgsu.edu.in</a> or using link <a href="https://dhsgsuadm.samarth.edu.in/">https://dhsgsuadm.samarth.edu.in/</a>

#### 1.1 Eligibility Criteria (as per UGC Regulations 2022):

1.1.1 Applicants who have completed following may apply:

A 1-year/2-semester master's degree programme after a 4-year/8-semester bachelor's degree programme or a 2-year/4-semester master's degree programme after a 3-year bachelor's degree programme or qualifications declared equivalent to the master's degree by the corresponding statutory regulatory body, with at least 55% marks in aggregate or its equivalent grade in a point scale wherever grading system is followed

Or

Equivalent qualification from a foreign educational institution accredited by an assessment and accreditation agency which is approved, recognized or authorized by an authority, established or incorporated under a law in its home country or any other statutory authority in that country to assess, accredit or assure quality and standards of the educational institution.

1.1.2 A relaxation of 5% marks or its equivalent grade may be allowed for those belonging to SC/ST/OBC (non-creamy layer)/Differently Abled, Economically Weaker Section (EWS) and other categories of candidates as per the decision of the Commission from time to time.

Provided that a candidate seeking admission after a 4-year/8-semester bachelor's degree programme should have a minimum of 75% marks in aggregate or its equivalent grade on a point scale wherever the grading system is followed. A relaxation of 5% marks or its equivalent grade may be allowed for those belonging to SC/ST/OBC (non-creamy layer)/Differently Abled, Economically Weaker Section (EWS) and other categories of candidates as per the decision of the Commission from time to time.

1.1.3 Candidates who have completed the M.Phil. programme with at least 55% marks in aggregate or its equivalent grade in a point scale wherever grading system is followed or equivalent qualification from a foreign educational institution accredited by an assessment and accreditation agency which is approved, recognized or authorized by an authority, established or incorporated under a law in its home country or any other statutory authority in that country to assess, accredit or assure quality and standards of educational institutions, shall be eligible for admission to the Ph.D. programme. A relaxation of 5% marks or its equivalent grade may be allowed for those belonging to SC/ST/OBC (noncreamy layer)/Differently Abled, Economically Weaker Section (EWS) and other categories of candidates as per the decision of the Commission from time to time.

- 1.1.4 Person With Disability (PWD): Visually Impaired and/ or Hearing Impaired and/or Orthopedically Handicapped (on horizontal reservation basis) candidates, have to submit a self- attested copy of Disability Certificate issued by the District Chief Medical Officer/Medical Board. The disability benefits will be given to those candidates only who have at least 40% physical impairments. The percentage of disability should be mentioned in the certificate.
- 1.1.5 Provisional admission shall be given only to those applicants who have appeared in the final year/semester examination of the qualifying examination and their result is awaited. The admission of such students shall be purely provisional and they will have to submit their result by a date as fixed by the department/university, failing which their provisional admission will automatically stand cancelled and fee paid by them shall stand forfeited. No representation in this regard shall be entertained at any level.
- 1.1.6 Applicant having supplementary/ATKT/backlog in any annual/semester examination and such supplementary/ATKT/backlog result is awaited at the time of interview shall not be granted admission.

#### 1.2 Duration of the Ph.D. Programme:

- 1.2.1 Ph.D. Programme shall be a full time programme.
- 1.2.2 Ph.D. Programme shall be for a minimum duration of three (3) years, including coursework, and a maximum duration of six (6) years from the date of admission to the Ph.D. programme.
- 1.2.3 A maximum of an additional two (2) years can be given through a process of reregistration as per the Statute/ Ordinance of the University; provided, however, that the total period for completion of a Ph.D. programme should not exceed eight (8) years from the date of admission in the Ph.D. programme. Provided further that, female Ph.D. scholars and Persons with Disabilities (having more than 40% disability) may be allowed an additional relaxation of two (2) years; however, the total period for completion of a Ph.D. programme in such cases should not exceed ten (10) years from the date of admission in the Ph.D. programme.
- 1.2.4 Female Ph.D. Scholars may be provided Maternity Leave/Child Care Leave for up to 240 days in the entire duration of the Ph.D. programme.
- 1.2.5 The Ph.D. Programme will run under the University Ordinance 23 (A) amended (with changes adopted time to time).

#### 1.3 Procedure for Admission to Ph.D. Programmes:

- (A) The University Grants Commission (UGC), vide its public notice No.F.4-1(UGC-NET Review Committee)/2024(NET)/140648 dated 27<sup>th</sup> March 2024, has decided that from the Academic Session 2024-25, the score of the National Eligibility Test (NET) can be used for admission to Ph.D. programmes in place of entrance tests conducted by the different Universities/HEIs.
- (B) Accordingly, Dr. Harisingh Gour Vishwavidyalaya, Sagar has decided to use National Eligibility Test (NET) scores for admission from the academic session 2024-25.
- (C) The marks obtained in UGC-NET-December 2024 or June 2025 (or other in equivalent National Test) shall be score of applicant for admission in Ph.D.
  - I. Provided, wherever in documents of national level test, the marks obtained is <u>not</u> mentioned, the **Normalized score** shall be treated as the marks obtained.

- II. If any of above mentioned scores are not available, **Percentile score** shall be used.
- III. In case of admission in Ph.D. programme in Pharmaceutical sciences, the <a href="NTA">NTA</a>
  <a href="Score">score</a> mentioned in the GPAT score card shall be considered. If such score is not provided in the score card, the **Percentile Score** shall be considered.</a>
- (D) Based on the scores obtained the applicant will be eligible for admission in either of the three categories (as per the notification of UGC No.F.4-1(UGC-NET Review Committee) /2024(NET)/140648 dated 27<sup>th</sup> March 2024):

- 1.3.1 The UGC-NET/ UGC-CSIR NET/ GATE/ CEED and other equivalent National Level Test qualified applicant will be admitted into the Ph.D. programme in accordance with the University Grants Commission (Minimum Standards and Procedures for Award of Ph.D. Degree) Regulations, 2022 and subsequent amendments.
- 1.3.2 The admission will be based on combined merit of NET (or other equivalent national level test) and marks obtained in interview. The same criteria shall be followed for GATE/GPAT or other equivalent national level test qualified applicants.
- 1.3.3 If obtained marks in National Level Test is Z out of total maximum marks N, then the 70% weightage will be calculated as  $\{(Z/N)x70\}$ .
- 1.3.4 The marks obtained in the UGC-NET December 2024 or June 2025 by the candidates in Categories 2 and 3 will be valid for a period of one year for admission to Ph.D.
- 1.3.5 Score of UGC-NET prior to December, 2024 shall not be valid for Ph.D. admission in the university for academic session 2025-26. However, the validity of JRF will be counted form as mentioned in the JRF Award letter.
- 1.3.6 The validity of JRF shall not be expired on date of admission, failing which the candidature for admission in the Ph.D. programme shall be automatically cancelled.
- 1.3.7 Admission to Ph.D. programme in Pharmaceutical Sciences will be on the basis of GPAT score. The candidate must have passed M.Pharm. /MS from PCI approved institution/NIPER/Department of recognized University.
- 1.3.8 As in the case of Category 2 & 3, due weightage to the NET score of Category-1

**candidates should be given** (i.e., not below 70% weightage of UGC-NET December 2024 or June 2025 (or other equivalent National Level Tests score).

#### 2.0 Interview & Merit List:

- 2.1 The university may decide the number of eligible applicants to be called for interview based on the number of vacant seats. A cut-off score may be decided, if so desired.
- 2.2 The date of the interview will be published by the Admission Cell of the university. The date, time and venue of the interview will be notified on the University website.
- 2.3 Eligible applicants will be called for interview (with a research proposal). The Departmental Research Committee (DRC) will discuss the research interest of applicant through presentation (preferably PowerPoint). Apart form research interest, the committee will also gauge aptitude and competence of applicant in research.
- 2.4 In case of same score (marks) of two or more applicants in final merit list, the order will be prepared on the basis of marks PG degree. If this also found same the marks obtained in UG degree will be considered. The seniority in age shall be the last option.
- 2.5 In case of any controversy/dispute, the decision of the University shall be final and binding.

#### 3.0 General Instructions:

- a) Admission Cell shall issue a common schedule of interview for all the subjects/programmes.
- b) The document verification will be held prior to the interview.
- c) The Admission Cell will compile the score provided by all members of the committee and the same will be published on the university website.
- d) The Vice-Chancellor may appoint observer for the interview, if so desired.

#### 5.0 Portal Registration Fee:

SC/ST candidates: Rs. 500/-PWD candidates: No Fee

Recurring Fee : 100/- (for each additional application/registration)

Correction Fee : 50/- (for each application/registration)

(2) Portal fee once paid shall neither be refunded nor transferred to another course nor will it be reserved for subsequent years in any case.

Note 5.1:Before applying and paying fee for registering in Ph.D. programmes, applicants must ensure that they have a Master's degree in the concerned/relevant/allied subjects with at least 55% marks in aggregate or its equivalent CGPA or equivalent Grade otherwise their claim for admission in Ph.D. programmes shall be rejected. The University shall not be responsible for such error.

#### 5.2 Instructions for form filling:

Applicants must ensure that they possess the following objects in hand before filling online applications:

- 1. A valid, active & self-mentioned e-mail ID for filling up the Application form. Applicants must insure that they are watching that e-mail ID regularly.
- 2. A Mobile Number of their own for filling up the Application form.
- 3. A recent passport size colored photograph (for scanning and uploading in JPG/JPEG format only. File size of the scanned photograph should be between 10 and 500KB).
- 4. Your signature using **Blue/Black** pen on a white sheet (for scanning and uploading in JPG/JPEG format only. File size of the scanned signature should be between 10 and 500KB).
- 5. Access to an online payment facility/service such as Net Banking/Credit card/ATM-cum-Debit card/UPI etc.

#### 5.3 Rejection of Application Form:

#### Following are the grounds for rejection of application and candidature:-

- (i) The absence of the **photograph/signature** of the applicant at the appropriate place in the application form and/or tempering of photograph/signature.
- (ii) Providing wrong information in the application form and/or the tempering in support documents.
- (iii) If, at any stage, it is found that the applicant is not eligible for admission to a course under University rules, his/her candidature will automatically stand cancelled.
- (iv) If eligibility degree is incomplete (except if last/end semester result awaited), such application shall be rejected.
- (v) If the candidate does not fulfill all the requirements for admission, or any error/deficiency/discrepancy found during the admission process or deliberate delay found in the given time line (or scheduled), adoption of mal-practices, indecent behavior found with the university authorities, in such the university reserves right to cancel the candidature of applicant at any time during the admission process, or even after admission.

#### PUBLIC NOTICE

#### National Eligibility Test (NET) as an Entrance Test for Admission to Ph.D.

The University Grants Commission conducts the National Eligibility Test (NET) through the National Testing Agency (NTA). The NET is conducted twice a year, in June and December. Currently, the NET scores are used (a) to award Junior Research Fellowship (JRF) and (b) as eligibility for appointment as Assistant Professor for those with a Master's degree.

Many universities conduct their entrance tests for admission to their Ph.D. programmes, requiring the students to write multiple Ph.D. entrance tests. To help the students with one national entrance test for Ph.D. admissions as a part of implementing the National Education Policy 2020, the UGC constituted an expert committee to review the provisions of the National Eligibility Test (NET).

Based on the expert committee's recommendations, in its 578<sup>th</sup> Meeting held on 13 March 2024, the UGC has decided that from the academic session 2024-25, the NET score can be used for admission to Ph.D. programmes in place of entrance tests conducted by the different universities/HEIs.

From June 2024 onwards, therefore, the NET candidates will be declared eligible in three categories:

Category-1: Eligible for (i) admission to Ph.D. with JRF and (ii) appointment as Assistant Professor.

Category-2: Eligible for (i) admission to Ph.D. without JRF and (ii) appointment as Assistant Professor.

**Category-3:** Eligible for admission to Ph.D. programme only and not for the award of JRF or appointment as Assistant Professor.

The result of NET will be declared in percentile along with the marks obtained by a candidate to utilize the marks for admission to Ph.D.

The JRF-qualified students are admitted into the Ph.D. programme based on an interview as per the University Grants Commission (Minimum Standards and Procedures for Award of Ph.D. Degree) Regulations, 2022.

For students who qualify in Categories 2 and 3, 70% weightage will be given for test scores and 30% weightage for the interview for admission to Ph.D. programmes. The Ph.D. admission will be based on the combined merit of NET marks and the marks obtained in the interview/viva voce.

The marks obtained in the NET by the candidates in Categories 2 and 3 will be valid for a period of one year for admission to Ph.D.

The notification and Bulletin of Information for the NET June 2024 will be issued by the National Testing Agency shortly at <a href="https://ugcnet.nta.nic.in">https://ugcnet.nta.nic.in</a>.


